I acknowledge and agree as follows:

- The membership hereby granted is personal to me and may not be assigned nor used by any person other than me. No guests allowed.**
- I will abide by the following rules and regulations (and any additional rules and regulations of which I receive notice):
 - I will not leave valuables or any personal items in the Fitness Facility or in the Change Room Facility. Any items left at close will be collected daily and turned in to lost & found. Unclaimed items will be disposed of in accordance with established procedures.
 - I will turn off showers after use.
 - I will inform the operator of any damage which occurs in the Fitness Facility.
 - I will wear proper attire in the Fitness Facility.** No office attire; no street clothes, jeans or pants with rivets or belts; no shoes other than runners.
 - I will not disrupt other members by talking on a mobile phone while in the Fitness Facility.
 - I will not consume alcoholic beverages or food in the Fitness Facility.
 - I acknowledge that the owner and operator have no obligation to supervise the use of the Fitness Facility.
 - I will use the equipment in a safe and proper manner and will not use any equipment if I do not understand its proper operation.
 - I understand that the Fitness Facility is for my use only and the use of a personal trainer is strictly prohibited without the prior approval of both the operator and HSG Health Systems Group Ltd.**
- My membership may be terminated immediately if I violate the terms of this agreement or I abuse the use of my pass card in any manner, such as but not limited to admitting non-members to the Fitness Facility (whether family or otherwise), or demonstrating improper actions or conduct which include, but are not limited to, verbal or non-verbal harassment, destruction of property, theft, assault, immoral or indecent conduct, and I agree any prepaid fee will be forfeited.
- My membership will terminate automatically if I cease to be a tenant or an employee of a tenant in the building.
- Notwithstanding anything in this waiver, The Cadillac Fairview Corporation Limited may, at its sole and unfettered discretion, terminate my membership at any time.

Release and Indemnity:

For good and valuable consideration, the receipt of which is hereby confirmed I, for myself and my heirs, executors, administrators, successors and assigns, hereby release, waive and forever discharge Ontrea Inc. by its duly authorized agent The Cadillac Fairview Corporation Limited and HSG Health Systems Group Ltd. (hereinafter referred to as the "Releasees") of and from all claims, demands, damages, costs, expenses, actions and causes of action, whether in law or in equity, in respect of death, accident, injury, illness, loss or damage to myself or my property howsoever caused arising directly or indirectly as a result of or in any way connected with this agreement or my use of the Fitness Facility, notwithstanding that the same may be contributed or occasioned by the negligence of the Releasees. I further undertake to hold and save harmless and agree to indemnify the Releasees from and against any and all liability incurred by it arising directly or indirectly as a result of or in any way connected with this agreement or my use of the Fitness Facility. I acknowledge that the term "Releasees" as used herein includes their officers, directors, agents, employees, workers, officials, servants, contractors, representatives, successors and assigns.
